5.	Finance Report:  Balance at 3 <sup>rd</sup> May is £3,511.70, including remaining £2,128 ring fenced for TERP. The grant and expenditure for the new notice board have been processed. The annual Community Council grant from Aberdeenshire Council of £542.67 and Data Protection Registration Fee of £35.00 has been received.	ED

The Planning Dept. has now provided a legible map and there are no particular concerns and trees screen the development. 	8.1. Old School House: Still no interest is reported. Cllr. PA has reinforced with officials the ring fencing of proceeds to fund an upgrade of the Learney Hall.	Cllr. PA
	8.2. Community Action Plan: No new report.	LM
	8.4. Torphins Emergency Response Plan: Aberdeenshire Council has advised the generator may be stored on site at the hall. A number of operational items have been purchased and more are being purchased with the SSE grant.	JL
	8.5. Newsletter:  The Newsletter narratives are complete with photographs and formatting in progress.  The Newsletter will include registration details for the TERP, which will also be made available online at torphins.net. LM will distribute the latest version for review and CR will look into final format preparation for printing. The Newsletter will be followed by Village Welcome Pack.  8.6. Notice Board:	LM
	The notice board is expected for delivery to Torphins this week with thanks to Alistair Arbuthnott and Addison haulage contractors. Installation on site will be by Aberdeenshire Council. ED is investigating the old board and following up on sale to Mid Deeside Community Council or other party if they are not interested.  8.7. Torphins Park:	ED
	The drainage situation continues to be monitored by Aberdeenshire Council in case problems do not resolve in drier weather.	JL
	It has now been confirmed the Council will paint the play park equipment over summer months.  8.8. Roads:  8.8.1. Extension of 30 mph limit north of village:	AC
	NP has written a gentle request to the Senior Roads Engineer to speed this matter, which has been open for many months to years.  8.8.2. Informal Laybys at Campfield Filling Station:	NP
	Cllr. PA advised Roads are pleased to close and fill the unofficial lay by to the east of Campfield Filling Station, and the owners agree. The unofficial lay by opposite the filling station is more difficult as delivery tankers use the area when turning into the filling station. Cllr. PA will review this again with Roads for a solution. CG suggested mirrors at the junction would help sight when pulling out at the junction but Cllr. PA advised Roads will not fit and do not support mirrors. JL suggested a flashing speed limit sign to improve behaviour. Cllr. PA advised the Council is moving away from fixed signs to mobile signs so there could be an opportunity for a mobile sign in future.	Cllr. PA
	8.8.3. LM raised a concern about the lack of visibility and exposure to pedestrians at the sharp left turn from Craigour Road onto Woodside Road. It was felt that in the current economic circumstances there is little likelihood of improvements here. Pedestrians are recommended to use alternative routes by Wellburn Park.  8.9. Overgrown Hedges and Vegetation:	LM
	Cllr. PG has sent the documentation to the Senior Roads Engineer, asking the Council to contact the listed residents and advising them of their responsibilities to maintain their hedges to ensure pedestrian movement is not impaired.  8.10 TCC Logo Proposal:	LM Cllr. PG AC Roads
	JL presented a draft logo for feedback prior to investing time in additional detail. The recommendation was deemed worthy of further work to finalise the new design.	JL

8.	8.11. Waste Bin on Learney Avenue:	
	It has been confirmed the Learney Avenue waste bin was removed illegally.	Cllr. PA
	Aberdeenshire Council has a new supply of bins at Banchory and will assign one to	AC
	Learney Avenue. This theft has created work and unnecessary expense for the	
	Council, who are nevertheless acting promptly to replace the bin.	
	8.12. Festive Lights Meeting:	
	ED recently attended a meeting with Aberdeenshire Council Infrastructure Services	ED
	officials on the matter of the new proposals for testing of lamp posts by Community Councils and other voluntary organisations who wish to fit festive lights, hanging	
	baskets, etc. to lamp posts, and the recharging to Community Councils the cost of	
	electricity used, rather than Aberdeenshire Council paying as in past. All this saves	
	£12,000 across Aberdeenshire. ED advised the meeting was frustrating with lack of	
	clarity and understanding by the officials, and when ED subsequently submitted a	
	schedule of lamp posts to obtain specifications from the owners, Aberdeenshire	
	Council, it was clear the officials did not understand their own proposals as they did	
	not know why he was asking. The proposals recommended by Infrastructure Services	
	officials will be very onerous and costly for Community Councils and others,	
	threatening the possibility of continuing to provide festive lighting.	
	Cllr. PA advised the elected members are well aware of the issues and concerns and	Cllr. PA
	the need for safety to be addressed. The proposals will be considered at a future	
	Infrastructure Services Committee meeting, of which committee Cllr. PA is Chair.	
	8.13. Dog Fouling:  JL has prepared and posted new posters to resurrect awareness and push again for	JL
	compliance by dog owners.	JL
	8.14. Torphins Paths Group Feasibility Report and Public Engagement:	
	WM advised TCC the feasibility study by Outdoor Access Trust for Scotland, primarily	WM
	funded by EU South Aberdeenshire LEADER and Marr Area Large Projects Grant has	
	been completed. The results were presented to a well attended public engagement	
	meeting of over 50 people at MDC Lochnagar on 24 <sup>th</sup> April 2018. The proposals are	
	for path developments in Torphins from William Street to Monboddo to MDC and	
	eastern end of Learney Avenue, plus development of green, blue and red routes in	
	Torphins Wood largely following the existing trod core path. Routes to Lumphanan	
	and Banchory have also been defined, substantially following the line of the	
	dismantled railway where feasible. The route to Banchory would initially follow the	
	Beltie Burn, providing a southerly leg to a Torphins orbital route, and is supported by the developer of the proposed Annesley housing site. All developments will be	
	subject to landowner agreement, however some agreements in principal have already	
	been achieved. The Group will also publish walking routes in the near future and will	
	begin a maintenance programme with volunteers, using the tools donated by	
	Aberdeenshire Council.	
	The public engagement meeting was unanimously supportive of the proposals, which	
	the Group now plans to advance with volunteer support, landowner agreements,	
	funding applications, and planning and design and build activities.

	following up on email already sent, with those interested asked to register.	
	9.2. An email has been received from Alexander Burnett MSP requesting he be added to the distribution of community councils. TCC agreed and added AR MSP	
	to the distribution of community councils. TCC agreed and added AB MSP.  9.3. Learney Hall curtains have been missing for some time after removal last year for	
	repair and cleaning by AC facilities dept. Cllr. PG has followed up and quotes are now	
	being obtained for the repair, clean and rehang of the curtains. Hopefully the saga	
	will be resolved soon.

	Following notification of the Strategic Development Plan Main Issues Report it was	
	agreed TCC would submit a response. The response has been submitted and has

10.	AOCB: 10.1. JL advised the new constitution will be tabled for approval at the TCC meeting on 7 <sup>th</sup> June 2018.	JL
	10.2. JL has requested James, the hall keeper to report the Learney Hall clock failure	JL
	to Claire at IS. The clock has stopped and the light has failed.	AC
	10.3. CL requested TCC preparation for Torphins Gala be added to the June meeting agenda.	CL/WM
	10.3. CG expressed his extreme concern about the major potholes on the unclassified road running north from Campfield Filling Station. The road is used by increasing numbers of vehicles, in particular heavy agricultural machinery. Specifically the damage to this road demands repair by Aberdeenshire Roads. More generally there is very significant concern that the lack of a proper planned maintenance for all roads in general is leading to major potholing and road degradation that will be more costly to remediate in the long run than proper ongoing preventive maintenance, such as regular surface dressing to prevent water ingress before problems arise. This is recognised as a national funding issue but one that needs a new approach.	CG
	10.4 CG also requested a pavement should be provided to connect the housing on this road running north from Campfield Filling Station due to the volume of traffic and risk for pedestrians. CG asked what are the standards that define when a pavement has	CG
	to be provided by Aberdeenshire Council.  10.5. Cllr. PG notified the meeting of the Aberdeen Health and Social Care Partnership Aberdeenshire Wellbeing Festival, which runs from 16 to 22 May and is highly recommended.	Cllr. PG
	10.6. HB requested more, smaller, sand boxes be provided by AC in the areas where elderly and less able people live. What are needed are many more localised small boxes rather than a few large boxes.	НВ
